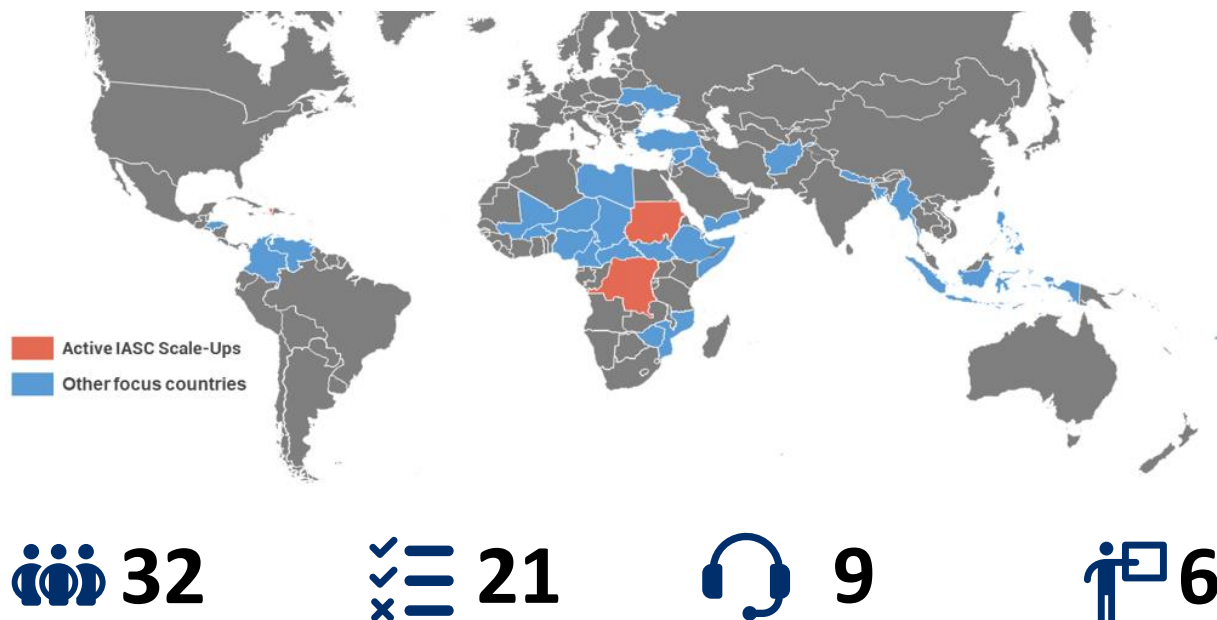


Putting people first
