WHAT IS THE EMERGENCY CAPACITY BUILDING (ECB) PROJECT?

Purpose: to improve the speed, quality, and effectiveness of the humanitarian community to save lives, improve the welfare, and protect the rights of people in emergency situations.









WHAT IS THE EMERGENCY CAPACITY BUILDING (ECB) PROJECT?

• Six Agencies

- CARE, CRS, Mercy Corps, Oxfam, Save, WV

• Three thematic areas

- National staff capacity development
- Disaster risk reduction and preparedness
- Accountability and impact measurement

• Five field consortia

– Bangladesh, Bolivia, Indonesia, Niger, Horn





NATIONAL STAFF CAPACITY

• Target Groups:

ECB

- Leaders, managers and field staff (non specialists)
- Tools and expected output:
 - Agreed core competencies
 - Agreed capacity assessment methods
 - Agreed curriculum and tailored learning package
 - Measure impact of learning
 - Emergency response simulations and learning
 - Working with OCHA in the field on simulations



DISASTER RISK REDUCTION

- Target Groups:
 - Practitioners in the field and regional/national coordinators
- Tools and expected output:
 - Practitioner's Guide to DRR/CCA:
 - emphasize simple and practical guidelines
 - present tools that are efficient, quick and easy to use for both risk assessment and DRR mainstreaming
 - Draft Guide to be piloted in first half of 2012, final version to be published in September 2012
 - In discussions with UNISDR on support and promotion of the Practitioner's Guide
 - ECB is an active participant in the IASC SWG on Preparedness



ACCOUNTABILITY & IMPACT MEASUREMENT



- Target Group:
 - Leaders, managers, and field staff who work directly with disaster-affected populations
- Tools and activities:
 - Joint Needs Assessment
 - AIM Standing Teams
 - Good Enough Guide Accountability to Beneficiaries
 - Good Enough Guide to Impact Measurement (end 2012)



ECB and IASC

- Accountability to Affected Populations Task Force
 - Have incorporated ECB's Five Pillars of Accountability into the IASC's Operational Framework
- Shelter Cluster
 - Full-time shelter specialist working with Shelter Cluster on improving cluster accountability to beneficiaries (currently in Cote d'Ivoire)
- Needs Assessment Task Force
 - ECB agencies working with ACAPS to produce joint needs assessments, sharing learning with NATF
