	<p>and emergency communication systems are typically overloaded, damaged, or destroyed. This inhibits emergency responders' ability to adequately sense, respond, coordinate, and effectively manage the emergency event. During such incidents, the need for a rapidly deployable communications system that enables the interoperability of responders to communicate with voice, data, and video becomes paramount.</p> <p>The team discussed further on what ERN is comprised in terms of hardware, software, and services pre-bundled into an end-to-end managed service that offers emergency preparedness, communications, networking, and deployable personnel with technical expertise to support situations that require incident management and emergency response solutions. As such, details of how ERN provides the enabling infrastructure and capabilities to support responders prior to, during, and throughout the close out of the emergency situation. The overall message was how an IP-enabled tactical data, voice, and video communications solution provides critical communications to the extended community of assets that enable an effective response to any incident.</p>
