Background: The IASC 61st Working Group, at its meeting held in Geneva on 22-23 June, decided to launch a joint analysis and consultation process to prioritise and take forward selected recommendations from the several studies and humanitarian reform initiatives currently before IASC members and to present a strategic action plan to the IASC Principals. In that regard, it was also agreed to fully dedicate the next IASC Working Group Meeting (6-7 September in New York) to the issue of ‘Better Humanitarian Response’. An external facilitator will support the work of the IASC WG Retreat.

Objectives:

1. Reach a common understanding of what it means to assume “primary managerial responsibility and accountability” for a cluster, that will be tabled at the discussion at the IASC Principals meeting on 12 September 2005.
2. Agree on which agency/ies will assume primary managerial responsibility and accountability for which Cluster Working Group, and recommend how to move forward to establish a system of cluster responsibilities by 2006, which will be discussed and finalised at the IASC Principals meeting on 12 September 2005.
3. Agree on actions to be taken by the IASC Working Group to address other issues that are critical to strengthening humanitarian action, taking into account various initiatives and processes including the Humanitarian Response Review, the follow up to the ECOSOC resolution, the upcoming General Assembly resolution and other relevant donor initiatives.

Proposed Outcomes

1. Recommendation of Action Plans¹ of cluster responsibilities and managerial accountability for each cluster, which will be presented to the Principals Meeting on 12 September 2005, for final decision.
2. Recommendation endorsing the Synthesis Report, which will be presented to the Principals Meeting on 12 September 2005 for final decision.
3. Recommendation of Action Plans² on the process to be followed to implement other Humanitarian Reform recommendations, which will be presented to the Principals Meeting on 12 September 2005, for final decision.

Session One: Cluster Responsibility and Accountability.

Introduction on the Sessions on Cluster Responsibility and Accountability

Richard Blewitt, the IASC WG Retreat facilitator, will introduce all participants and explain the methodology and objectives of the sessions.

The main objectives of the sessions on Cluster Responsibility and Accountability are:

- Review and agree on key issues addressed in the Synthesis Report including 1) definition of the role and responsibilities of a Lead agency and 2) inter-sectoral coordination.
- Review and agree on which IASC agency/ies should be the Lead agency of each Cluster Working Group on a global basis.
- Review and agree on key outstanding issues by Clusters.

The suggested methodology for the sessions is the following:

1. The presenter of the Synthesis Report will briefly introduce the report as per cross-sectoral issues identified. Each presentation (by issue) will be followed by a discussion.

2. The chair of each Cluster Working Group (CWG) will make a brief PowerPoint presentation (total of four slides, for a five-minute presentation per each CWG) highlighting: (a) Key outcomes of the Cluster Working Group Report including proposal for the Lead agency, (b) Outstanding issues which require IASC WG discussion, (c) Suggestions from the Cluster Working Group on how to resolve outstanding issues, and (d) How would we like this Cluster to look like one year from now.

3. Presentations will be followed by discussion in order to review and to agree on the proposals made by the Synthesis Report and by the Cluster Working Groups.

4. Any outstanding or unresolved issue will be discussed by the participants in smaller groups in the afternoon in order to reach a common position (consensus or non-consensus) to be later reviewed in a plenary session.
