IASC Weekly Meeting 1 June 2005 Notes



1: Afghanistan: Status of Civil Military Relations and Coordination (Introduction by Afia Ali Blasco, OCHA; Presentation by Diego Osorio, CMCoord Officer, OCHA/United Nations Assistance Mission in Afghanistan (UNAMA))

Ms. Afia Ali Blasco, Humanitarian Affairs Officer in OCHA's Africa I, North Africa, Middle East and Afghanistan Section introduced the theme, and gave a short briefing on the expansion of the International Security Assistance Force (ISAF), civil-military relations as well as OCHA's support to UNAMA.

Mr. Diego Osorio, Civil-Military Coordination Officer in OCHA/UNAMA briefed on his role as CM coordinator as well as the general status of the civil-military relations.

A vital task is to improve the interface between the civil and military actors, which includes the adoption of the IASC civil-military guidelines to the situation. The position of OCHA is that an ISAF expansion should be done to promote security, and that Provincial Reconstruction Teams (PRT) should always distinguish themselves as military. Civil assistance should be given only when necessary, for instance if the location is remote and no civil actor is in place.

The CM Coordinator act as liaison officer and coordinates the flow of information from both civil and military actors as well as arrange and set up meetings between the to sides. Three working groups have been set up: i) PRT working group; ii) NGO civil-military working group; and iii) UN agencies Civil-military focal points collective.

The civil-military relations in Afghanistan are ambiguous, and the legal framework for the coalition soldiers is unclear. The reconstruction strategy is national, central and Government-led, and includes humanitarian actors, development actors and the military forces. Coordination however remains unclear.

Mr. Osorio underlined that the position of UNAMA is that the military forces are not humanitarian actors, but are at times when it is needed, and are getting better in this work. PRTs are considered useful when rightly applied.

In the discussion following the briefing it was stressed that the situation in Afghanistan is still not post-conflict.

2: Briefing on IDD mission to Liberia

Mr. Marc Vincent, Acting Chief of IDD's Protection and Policy Section, briefed on the IDD mission to Liberia, 8-22 May, which was a follow-up to the mission of October 2004. The purpose was to review the implementation of the November 2004 Action Plan for the Return and Reintegration of IDPs and to assist the HC and the IDP Consultative Forum in establishing a comprehensive monitoring mechanism to address protection issues for IDPs in camps and during the return process.

In November 2004 the return process was initiated for an anticipated total number of 314.000 IDPs. The WFP, UNHCR and IOM provided transport assistance, to over 145.000 IDPs, many of who have returned to their place of origin. Since then the procedure has changed. Instead of providing transport, IDPs are now given cash-allowances and are left to make their own way from the camps. The change of procedure was urged upon the CT by the Government who wanted the return process speeded up to get people home before the election in October this year.

These changes were not followed by a clear Action Plan, and there is a clear lack of protection monitoring and transportation. Furthermore the returnees are having difficulties in getting the return package back on foot, which will be made even more difficult by the approaching rainy season. Also, the voluntariness of the return has become difficult to determine.

Among its conclusions, Mr. Vincent mentioned, that the mission recommends that the transportation facilities be restored; that a resettlement policy is developed for those who wish to stay in the camps for the time being; that the protection monitoring is improved (UNHCR is asked to expand its presence and NGOs to do more protection monitoring, especially on Sexual and Gender Based Violence (SGBV), which remains a major issue in Liberia. UNICEF has been requested to provide support to NGOs when needed); and that coordination should be improved (the departure of OCHA in November 2004 has created major coordination problems as no proper follow-up structure was set up).

Mr. Vincent furthermore underlined that the return process is hampered by lack of pull-factors, with no infrastructure or job-opportunities in the return areas. A major concern and constrain in this regard, is the lack of funding.

In the discussion following the briefing the question of Disarmament, Demobilisation, and Reintegration (DDR) was brought up, and the need to reintegrate the former combatants reiterated. Finally it was underlined that the areas of return must be able to provide the returnees with basic services upon return.

MSF Briefing on Sudan)

The two had been released, but with accusation of false reports, spy activities etc. Accusations came from the release of the MSF report on Darfur in March 2005, where the Sudanese government's interference is stated.

 The launch is coordinated by The Foundation for the Refugee Education Trust (RET) in close association with UNESCO, UNHCR, UNICEF, Norwegian Refugee Council (NRC) and International Rescue Committee (IRC). The launch will include a briefing on the consultative development process and the content of the standards, the standards

handbook, and a discussion of plans to promote and implement the minimum standards around the world.
