

## 1: Mission Debriefing on Panama - Establishment of an OCHA Regional Office for Latin America and the Caribbean (by Fabrizio Gentiloni, OCHA)

Mr. Fabrizio Gentiloni, Assistant Director in Geneva of OCHA's Coordination and Response Division briefed on his recent mission to Panama.

Currently, OCHA is establishing a Regional Office for Latin America and the Caribbean in Panama. The office will be set up in the same compound as other UN agencies approximately 10 km from the centre of Panama City. 3 internationals, 4 locals and one national will staff the office. Two of the international posts are to be filled – one at L-5 level who will head the office and a second at L-3 level. The posts will be announced on ReliefWeb during April and should be filled-thereafter to prepare for the hurricane season, which starts in the summer.

The main tasks for the office will be disaster response and contingency planning, as well as monitoring the region with regard to possible complex emergencies. The regional office will work to assist and liase with the country offices in the region.

Following the briefing there was some discussion on the link with other UN offices working in and from Panama as well as some comments on OCHA regional offices in general.
