Mr. Jan Egeland, Secretary General, Norwegian Refugee Council (NRC)



SG of NRC since 2013. From 2011 to 2013, Mr. Egeland was the Europe Director of Human Rights Watch. As UN Under-Secretary-General for Humanitarian Affairs and Emergency Relief Coordinator from 2003 to 2006, Egeland helped reform the global humanitarian response system. From 1999 to 2002, he was the UN Secretary-General's Special Adviser on Colombia, and from 1990 to 1997 he served as State Secretary in the Norwegian Ministry of Foreign Affairs where he was among the initiators of the peace negotiations that led to the Oslo accords between Israel and PLO in 1993.

Deputy Special Representative of the Secretary-General to the United Nations Assistance Mission for Iraq (UNAMI), Resident Coordinator, Humanitarian Coordinator and UNDP Resident Representative in Iraq. Ms. Grande has previously served with the United Nations in India, South Sudan, Democratic Republic of Congo, Armenia, Angola, East Timor, Tajikistan, Sudan, Occupied Palestine Territories and Haiti. Ms. Grande's experience spans development, humanitarian action and peace-keeping.

Dr. Faizal Perdaus, President MERCY Malaysia and Chair ICVA Consortium



President of MERCY Malaysia since 2010 and the first Asian to be elected as Chair of ICVA. Physician by training, Mr. Perdaus' involvement with MERCY Malaysia began in 2003, when he signed on as a volunteer and became a member of MERCY Malaysia's Executive Council the same year. He headed the Drug Rehabilitation and Assistance Programme in Malaysia from 2003 to 2006, before being elected as President in 2010. In 2014, he was also appointed to the Board of Trustees for MERCY Malaysia UK (MMUK). Dr. Ahmad Faizal's tours of duty include Sri Lanka (2003), Iran (2004), Sudan (2004, 2008), Indonesia (2005, 2006), Pakistan (2005), Myanmar (2008), Syria (2013) and Philippines (2013).
