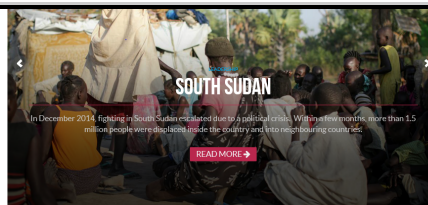

### IASC ad hoc Working Group meeting

The IASC Working Group met in an ad hoc meeting on 7 July to discuss the IASC Protection Policy and post-WHS follow-up. The draft policy was broadly welcomed by the Working Group members and the proposed revisions will be reviewed and endorsed electronically. The proposal to review the workplan in view of the WHS outcomes was welcomed, but deferred to a later date, pending finalization of the WHS commitments analysis. The WG endorsed the proposal to have a time-bound Task Team to draft the guidelines for the Charter of Inclusion of Disability in humanitarian action, as launched at the WHS. Finally, the Chair presented a progress update on the IAHE Evaluations on the Central African Republic, South Sudan and the Philippines.

### IASC Briefing on Jordan (1 July, New York)

The briefing by Mr. Edward Kallon, UN Resident Coordinator/Humanitarian Coordinator, focused on the operational challenges in Jordan, innovations that have been applied to address these challenges, the cross-border operations from Jordan to Southern Syria, and the humanitarian situation at the Berm. Despite the ongoing attention to humanitarian needs and follow-up to the commitments and pledges made in London, the UN Country Team has initiated a resilience based approach to planning as a bridge to the humanitarian and development assistance. Mr. Kallon noted that the current situation at the Berm is a true test of the humanitarian principles.

### IASC Briefing on the Humanitarian Negotiations Exchange Platform (HNx) (8 July, Geneva)

On 8 July, ICRC colleagues Claude Bruderlein, Head of Project (ICRC HNx and Centre of Competence) and Omar Odeh, Senior Project Officer (ICRC HNx) on Humanitarian Negotiation Exchange Platform (HNx). The HNx Platform has been designed to capture and analyze ICRC's negotiation practices as well as facilitate the sharing of negotiation experiences among ICRC practitioners and beyond, in full respect of the rules of confidentiality of the ICRC. In parallel and following informal consultations on the need to capture and share experience on frontline negotiations, HD, ICRC, MSF, UNHCR and WFP have established a Strategic Partnership to facilitate peer-to-peer interactions among humanitarian professionals active on the frontlines. ### STAIT Webinar on Localisation (19 July)

### The Real-Time Accountability Partnership on GBV in Emergencies

The International Rescue Committee, OCHA, UNFPA, UNICEF, UNHCR, and USAID's Office of United States Foreign Disaster Assistance are pleased to announce a global, multi-agency initiative on addressing gender-based violence (GBV) in emergencies, the Real-Time Accountability Partnership (RTAP). This global, multi-agency initiative on addressing gender-based violence in emergencies aims to harness the collective power of the humanitarian community to ensure that all individuals, particularly women and girls, are free from the threat of GBV. Specifically, the RTAP's goal is that all actors prioritize and coordinate GBV response services and integrate GBV prevention across sectors from the outset of an emergency.

### The Real-Time Accountability Partnership on GBV in Emergencies In Rwanda, research finds cash assistance for refugees boosts local economy for nearby communities

A recent study conducted by a team of researchers from WFP and the University of California, Davis, provided evidence of [the presence of refugees boosting the local economy of host communities](#), whether it be linked to cash or in-kind assistance. Specifically, researchers focused on three Congolese refugee camps located in Southern Rwanda – Kigeme, Gihembe and Nyabiheke - and measured the local-community impact within a 10-kilometre radius from the camps of different tools for humanitarian assistance, namely in-kind and cash assistance. In Kigeme – the only refugee camp receiving in-kind food assistance – for every dollar's worth of food, the real host-community income increased by \$1.19. In Gihembe and Nyabiheke – both receiving cash assistance –, there was a similarly positive correlation between humanitarian assistance and the local economy's wealth, but significantly greater, amounting to \$1.51 and \$1.95 respectively. Such increase translated into a 63% and 96% rise in the annual income of Rwandan households next to these sites. After the surveys were conducted last year, WFP switched to providing cash instead of food for refugees in Kigeme camp, and the researchers hope to conduct a follow-up study to measure the impact of that change.

## LESSONS FROM 14 COUNTRIES

In June 2016, WFP, jointly with the World Bank Group and the Partnership for Child Development of the Imperial College of London, published their third analysis on lessons learnt and on best practices for school feeding programmes. The collection of data took place between 2011 and 2014 in 14 countries - Botswana, Brazil, Cape Verde, Chile, Côte d'Ivoire, Ecuador, Ghana, India, Kenya, Mali, Mexico, Namibia, Nigeria, and South Africa – and included both primary and secondary data. Evidence shows that school meals are sustainable and widely applied worldwide, but context is key when it comes to choosing between centralized or decentralized approaches, as so it is for the size of the program, or the trade-off between public and private sectors. Features that support the overall effectiveness and quality of such programs are capacity-led planning at the national and sub-national levels, co-ordination supporting cross-sectoral linkages, and mechanisms to ensure accountability and quality assurance. Best practices resulting from the report include the use of food bought locally, such as in Brazil for example; the provision to school targeted children with 30% of the Recommended Dietary Allowance for energy; and the use of a strong country-specific regulatory system to allow good management, as well as to meet institutional goals and standards. The programmes are increasingly also covered by private sector investment.

## Early Recovery Online Resource Centre

The interagency Global Cluster for Early Recovery (GCER) has launched a new website to provide more context and information on Early Recovery and to support the humanitarian and development partners to better integrate Early Recovery into their work. The Early Recovery website is an online resource centre based on a modular information architecture that allows the organization, display, and search of documents, guidance, and tools according to the needs of the reader. Two links: “What is Early Recovery” and “Integrating Early Recovery” inform the visitors about the principles of this coordinated approach. The website gives access to an open-source, one-stop shop for documents, tools and guidance on Early Recovery and resilience strengthening in the context of a humanitarian crisis. ## World Food Programme launches innovation accelerator to test drive hunger solutions

On July 11th, WFP officially launched its new Innovation Accelerator based in Munich, Germany. As part of its efforts to support the achievement of Sustainable Development Goal 2 and end hunger by 2030, WFP's Executive Director Ertharin Cousin stressed that “we must capture the benefits of new technologies and the revolution in big data [and] we must boldly seek new ideas, tools and solutions that make more food available, accessible, and ultimately give every person everywhere the ability to feed her or his own children”. The Accelerator is a dedicated hub that combines WFP internal staff with experts and entrepreneurs to collaborate on three ideas proposed by WFP innovators for
