Norwegian Refugee Council statement on the Grand Bargain

The Norwegian Refugee Council (NRC) has invested energy and resources in the Grand Bargain (GB) since its inception during the World Humanitarian Summit in 2016. Three years in and NRC is taking stock of the accomplishments made but also, our participation in the reform process that is on course to achieve its raison d'être: to improve the efficiency and effectiveness of humanitarian aid.

Following this year's Annual meeting of signatories, we felt a renewed sense of optimism for the nature and intent of the GB and are excited to work with Minister Kaag, of Kingdom of the Netherlands, as the Eminent Person in our role as co-conveners of the enhanced workstream on quality funding. In taking on this role, NRC looks forward to a lighter process delivering a more impact-oriented approach working collectively across all constituencies: donors, United Nations and NGOs.

In line with the commitments to improve transparency, reduce management costs, and harmonise reporting, NRC will shortly launch a proposal to harmonise cost classification and financial budgeting and reporting. This will signify a new arrangement between donors and aid agencies, one through which both groups can build upon their respective commitments for greater transparency.

The proposal is based on *The Money Where It Counts* initiative, the culmination of our three-year project developed first in partnership with the Boston Consulting Group, and now with Humentum in this final stage. We belief that the proposal brings significant opportunities to achieving the Grand Bargain, calling on donors and aid agencies to collaborate – and compromise in the spirit of *quid pro quo* – for the adoption of a protocol outlining the main principles of cost classification and financial reporting. It embraces the original spirit of the bargain and moves beyond targeting the low hanging fruit while maintaining a realistic approach through the collaborative design of the initiative in which nine medium and large international NGOs were involved.

NRC and Humentum are now actively reaching out to potential donors to join with a group of INGOs to support the implementation of a pilot project with a structure similar to the one successfully steering the harmonisation of narrative reporting.
