OCHA's Grand Bargain Commitments to Localization




OCHA'S GRAND BARGAIN COMMITMENTS ON LOCALIZATION

Grand Bargain commitment to provide **25%** of funding to national responders

CBPFs are largest direct source of funding for national partners, exceeding 25% target from 2017

In 2018, **CERF** recipient agencies subgranted **\$73M** (14.5%) to national partners





CBPFs: SUPPORT TO THE LOCALIZATION AGENDA

CBPFs provide funding to actors which are "best placed" to support agreed strategies - most funding (62%) goes directly to **front-line responders** including national NGOs (40%)

CBPFs promote participation of local actors in **governance mechanisms** -- 17/18 CBPFs have at least two national NGOs on the Advisory Board

CBPFs promote participation of local actors in **project review and selection processes** -- 18/18 CBPFs involve national NGOs in strategic and technical review committees

CBPFs invest significant effort in **training for national NGOs**: over 150 training sessions held for 560 local partners in 2019. Development of new training modules in progress


Engagement and collaboration with the **NGO Dialogue Platform**, including over 200 national NGOs, to ensure that feedback and concerns are considered

CBPFs promote the work of local actors in donor reporting and public communications



CBPFs: SUPPORT TO FRONTLINE RESPONDERS IN 2020


40% of the total allocated by CBPFs in 2020 to date is for national NGOs (\$256M)






CERF: SUPPORT TO THE LOCALIZATION AGENDA

- CERF encourages partnerships with national and local organizations in the implementation of grants and tracks the flow of funding to implementing partners
- In 2018, CERF recipient agencies sub-granted \$73M (14.5%) to 567 national/local partners
- CERF and the CERF Advisory Group have worked with agencies to ensure faster disbursement of funds to implementing partners

OCHA's Support to Front Line Actors during the COVID Response



POOLED FUND 2020 ALLOCATIONS

CERF AND CBPF

\$1.4 billion allocated by CERF and CBPF so far in 2020

- \$730 M from CERF to 53 countries
- \$665 M from CBPF to 18 countries

COVID-19 RESPONSE

Of the total, 25% (\$344 million) allocated to COVID response

- \$134 M from CERF to 46 countries,
- Of which 19% allocated directly to NGOs
- \$210 M from CBPF to 18 countries
- Of which 62% to NGOs

COVID FUNDING IS EXPECTED TO REACH 82 MILLION PEOPLE IN 48 COUNTRIES




CBPFs: SUPPORTING THE FRONTLINE RESPONSE TO COVID-19

- \$210M to support 42M people in 18 countries
- Over 500 humanitarian projects

A localized response

- 28% of funding (\$56.8 million) to national responders
- Includes 118 national NGOs and 4 RC/RC national societies





Includes funds received as primary recipients and as implementing partners of other primary recipients (sub-grants)

CBPFs: SUPPORTING THE FRONT-LINE RESPONSE TO COVID-19

CBPFs put in place a set of "flexibility measures" in the area of budget, administration and risk management, while maintaining a robust oversight

- ✓ Aligned with IASC RG5 guidance
- ✓ Built on NRC-OCHA study
- Received favorably by partners.
- Will be reviewed for wider applicability.

Fast-tracked and simplified arrangements:


reprogramming of activities blanket no-cost extensions discretionary cost extensions raised budget ceilings flexibility in the use of budget lines



CERF: SUPPORTING THE FRONT-LINE RESPONSE TO COVID-19

\$25M allocation specifically for NGOs

- 26 NGO projects supporting 1.38M people
- 1/3 are national NGOs
- 6 countries prioritized
- 4 Sectors Health, WASH, GBV, child protection





CERF: SUPPORTING THE FRONT-LINE RESPONSE TO COVID-19

Initial Lessons from the NGO Allocation:

- Smooth NGO selection process, engaged HCs
- NGOs granted comparable terms to UN agencies
- High-quality project proposals
- Contracting 26 partners takes time
- Positive feedback from NGO consortia

More lessons to be collected via survey and consultations

TRACKING FUNDS TO FRONT LINE RESPONDERS

Financial Tracking System

- Voluntary reporting but more NGOs have reported funding contributions to FTS this year than in previous years.
- FTS has more accurately tagged "pass through" funding, whose percentage (out of the total funding) increased in 2020 compared than in 2019.
