Geneva, 28 November 2022

When: 8.00 to 16.30 Geneva Time on Monday, 28 November 2022.

Where: The Auditorium Z1 at the World Health Organization (WHO)

(Address: Avenue Appia 20, 1211 Genève, Switzerland).

Who: The morning session (from 8.00 to 12.50) is **limited to IASC Principals**, while the

lunch and the afternoon session (from 12.55 to 16.30) is open to "plus 1".

Security: Visitor badges are required for all confirmed participants. In addition, prior

registration, including uploading the COVID-19 vaccination certificate¹, to <u>INDICO</u>, is <u>mandatory</u>. Badges will be available at the WHO security desk on Friday, 25 November and during the weekend, or upon arrival on Monday, 28 November. Please arrive at least 15 minutes in advance, to ensure the meeting starts promptly. All meeting participants will be welcomed at the reception and accompanied by IASC

secretariat staff to the meeting room.

<u>Coffee:</u> Croissants and coffee/tea will be served next to the Auditorium at the scheduled

coffee breaks (08.00 to 8.30; 10.10 to 10.20). Hot beverages and water will be

available throughout the meeting.

Lunch: Lunch for the Principals will be offered at the WHO Restaurant, and for the plus ones

Accommodation:

Transportation:

Parking space at WHO is very limited and visitors are encouraged to use public transportation. The general traffic regulations and rules for parking in the WHO grounds or their immediate vicinity are the same as those in force throughout Switzerland.

Taxi: For taxis, participants should make a reservation at least 30 min in advance with Taxiphone Genève at +41 22 33 141 33.

Bus: Buses F, 22 and 8 run from Geneva's Cornavin railway station and from Nations to the '*OMS*' stop, then you can walk to the WHO building (approx.1 min. walk). You can find updated timetables and maps at www.tpg.ch.
